1. This application is filed on behalf of the Plaintiff under Order XI Rule 1(5) and Rule 1(1)(C)(II) read with Section 151 CPC seeking leave to file additional documents.
2. Mr. Jayant Mehta and Ms. Swathi Sukumar, learned Senior Counsels



for the Plaintiff submit that necessity to file the additional documents has arisen owing to subsequent developments that have occurred after institution of the suit. Defendant No. 8 entered appearance on 12.03.2024 and filed I.A. No. 6180/2024 seeking vacation of interim injunction order dated 21.09.2023 and in the said application, it is asserted that all copyrights in the works of His Divine Grace A.C. Bhakativedanta Swamy Prabhupada stood assigned to BBTI under an Assignment Deed dated 24.03.2019, which allegations are factually incorrect and this will be established by the additional documents.

3. Issue notice to Defendant No. 8.

4. Mr. J.V. Abhay, learned counsel accepts notice on behalf of Defendant No.8.

5. For the reasons stated in the application, the same is allowed. Additional documents are taken on record.
