1. Learned counsel for MCD submits that written synopsis and judgments with index was filed on 07.05.2024 in LA APP.452/2009 & LA APP.557/2009, however, the same was re-filed on 20.05.2024 after removal of objections pointed out by the Registry.  6. It is more than one year and Union of India has not filed written synopsis, judgments and convenience compilation.
 7. Learned counsel for Union of India submits that he would file written synopsis, judgments and convenience compilation within three weeks after receiving a draft thereof from appellants **(India Export House Pvt. Ltd.)** in LA APP.452/2009. Let the needful be done.
 8. Re-notify on 29.11.2024.

9. Pleadings qua respondent No.2 is already complete.
 10. Last opportunity is granted to respondent No.1 to file reply within four weeks. Rejoinder, if any, be filed before the next date.
