1. Learned respective counsels for the defendant
no.1&2, 10&12 already submitted that they do not wish to
file any reply to the captioned IA.

2. The right of defendant no.3,4&11 to file reply has
already been ordered to be closed.

3. **Pleadings qua defendant no.5 to 9 are already
complete.**

4. At the request of the plaintiff, place the captioned IA
before the Hon'ble Court on **05.05.2025**, for further
directions.

by the plaintiff for exemption from serving notice to D-
11 and D-12)**



5. Learned respective counsels for the defendant no.1&2 and defendant no.5 to 9 and D-10 already submitted that they do not wish to file any reply to the captioned IA.

6. The right of the defendant no.3,4 & 11 to file reply has already been ordered to be closed.

7. **Pleadings qua defendant no.12 are complete.**

8. At the request of the plaintiff, place the captioned IA before the Hon'ble Court on **05.05.2025**, for further directions.

9. Written Statement alongwith Affidavit of Admission/Denial of the documents filed by the defendant no.1&2 was taken on record vide order dated 24.01.2024.

10. Vide order dated 16.07.2024, the right of the plaintiff to file Replication qua defendant no.1&2 was ordered to be closed.

11. The right of the defendant no.3&4 to file Written Statement has already been ordered to be closed.

12. Vide order dated 09.11.2023, Written Statement alongwith Affidavit of Admission/Denial of the documents filed by the defendant no.5 to 9 were taken on record. As per record, defendant no.5 to 9 have also filed documents alongwith Written Statement. The Right of the plaintiff to file Replication alongwith Affidavit of Admission/Denial of the documents qua defendant no.5 to 9 was ordered to be closed vide order dated 21.02.2024

13. Vide order dated 22.12.2023, Written Statement alongwith Affidavit of Admission/Denial of the documents filed by the defendant no.12 was taken on record. The



right of the plaintiff to file Replication to the Written Statement of defendant no.12 was ordered to be closed vide order dated 21.02.2024.

14. It is stated by learned counsel for the plaintiff that he has supplied the complete paper book to learned counsel for the defendant no.10 on 21.10.2024. However, till date neither any Written Statement has been filed nor anyone is present on behalf of the defendant no.10 today to explain in this regard. So, in view of judgment passed in “***Ms. Charu Agarwal Vs. Mr. Alok Kalia & Ors.***, 2023/DHC/001454” the right of defendant no.10 to file Written Statement is ordered to be forfeited.

15. The right of defendant no.11 to file Written Statement has already been ordered to be closed.

16. **Thus, pleadings in the suit are complete.**

17. The plaintiff is directed to share draft of Joint Schedule of the documents with learned counsels for the defendants within three weeks. Learned respective counsels for defendants are directed to either provide their inputs, if any, to the draft of Joint Schedule of the documents or to provide the signed copy of Joint Schedule of the documents to learned counsel for the plaintiff within two weeks thereafter. The plaintiff is directed to file soft copy as well as physical copy of Joint Schedule of the documents within two weeks thereafter with copy to the opposite side.

18. Parties are directed to file hard copy of the documents of which e-copy already filed on record, if not filed earlier, at least two weeks before the next date of hearing.
