Matter is taken up through physical hearing as well as video conferencing.

Reply has been filed by defendant no.2. Other defendants have not filed any Reply till date. Reply, if any, may be filed by the newly impleaded defendant no.6 within 4 weeks with advance copy to the opposite party.
