1. Office noting indicates that affidavit of service has not been filed by the plaintiff.
2. Ld. Counsel for defendant no.2 seeks time for filing reply to the captioned IA.
3. Affidavit of service not filed in terms of order dated 25.04.2022 with respect to service of LRs of defendant no.3, defendants no.4 and 5.

8. Re-notify the captioned IA for completion of pleadings and consideration on **26<sup>th</sup> September, 2022.**
