1. As per office noting, nothing fresh has been filed.
2. No reply to the captioned IA was filed on behalf of the defendant no.2.
3. Ld. Counsels for plaintiff and defendant no.2 submit that talks of settlement are going on. Adjournment sought. Heard, allowed.
4. There is no report of issuance of notice of the captioned IA to LRs of defendant no.3 and defendants no.4 and 5 in terms of order dated 26.09.2022. Let report be called from Registry in this regard.
5. In the meantime, let fresh notice of the captioned IA be issued to LRs of defendant no.3 and defendants no.4 & 5 through all permissible modes, for next date of hearing.



6. No fresh address of the defendant no.1 has been filed on behalf of the plaintiff till date.
7. At request, on filing of fresh address of defendant no.1 by the plaintiff, issue notice of captioned IA to the defendant no.1 on fresh address through all permissible modes for next date of hearing.
8. Re-notify the captioned IA for completion of service, completion of pleadings and further proceedings on **05th April, 2023.**

CC 14/2022 (on behalf of defendant no.2)

1. As per office noting, nothing fresh has been filed.
2. Memo of parties with respect to the present counter-claim not filed on behalf of the counter-claimant. Time sought. Let the same be filed before next date of hearing.
3. No written statement to the counter-claim has been filed on behalf of the respondent/plaintiff.
4. Ld. Counsel for counter-claimant and Ld. Counsel for the respondent/plaintiff submit that talks of settlement are going on. Adjournment sought. Heard, allowed.
5. The respondent/plaintiff may file written statement to the counter-claim as per law with advance copy to opposite party, who may file replication thereafter as per law..
6. There is no report for issuance of notice of the counter-claim to the remaining respondents in terms of order dated 26.09.2022. Let report be called from Registry.
7. Subject to filing of memo of parties, summons be issued to the remaining respondents for next date of hearing.
8. Re-notify the counter-claim for completion of service, completion of pleadings and further proceedings on **05th April, 2023.**

1. As per office noting, nothing fresh has been filed.
2. An application for bringing on record LRs of defendant no.3 is pending for consideration.
3. Ld. Counsels for plaintiff and defendant no.2 submit that talks of settlement are going on. Adjournment sought. Heard, allowed.
4. Written statement and affidavit of admission/denial of documents already filed on behalf of defendant no.2.
5. No written statement and affidavit of admission/denial of documents has not been filed on behalf of the defendants no.4 and 5. Same be filed as per law with advance copy to the plaintiff, who may file replication within two weeks thereafter.
6. Let the pleadings be completed as per law.
7. Re-notify the matter for further proceedings on **05th April, 2023.**
