**I.A. No.5312/2022 (by plaintiff u/O XXII Rule 4 r/w
Section 151 CPC to bring on record LR of the defendant
no.3)**

1. No reply to the captioned IA was filed on behalf of the defendant no.2. Time sought. Let the same be filed within four weeks and rejoinder thereto be filed within two weeks thereafter.
2. PF not filed and hence, notice of the captioned IA not issued to LR of defendant no.3 and defendants no.4 & 5 in terms of order dated 26.09.2022 and 31.01.2023.
3. No fresh address of the defendant no.1 has been filed on behalf of the plaintiff till date.
4. Ld. Counsels for plaintiff and defendant no.2 submit that talks of settlement are still going on. Adjournment sought. Heard, allowed.



5. In the meantime, let fresh notice of the captioned IA be issued to LRs of defendant no.3 and defendants no.4 & 5 through all permissible modes, for next date of hearing.
6. At request, on filing of fresh address of defendant no.1 by the plaintiff, issue notice of captioned IA to the defendant no.1 on fresh address through all permissible modes for next date of hearing.
7. Re-notify the captioned IA for completion of service, completion of pleadings and further proceedings on 25th August, 2023.

CC 14/2022 (on behalf of defendant no.2)

1. As per office noting, nothing fresh has been filed.
2. Memo of parties with respect to the present counter-claim not filed on behalf of the counter-claimant. Time sought.
3. The counter-claimant may file amended memo of parties within four weeks.
4. As per office noting, PF not filed and hence, summons not issued to the respondents.
5. Subject to filing of memo of parties, summons be issued to the remaining respondents for next date of hearing.
6. Ld. Counsel for counter-claimant and Ld. Counsel for the respondent/plaintiff submit that talks of settlement are still going on. Adjournment sought. Heard, allowed.
7. The respondent/plaintiff may file written statement to the counter-claim as per law with advance copy to opposite party, who may file replication thereafter as per law.
8. Re-notify the counter-claim for completion of service, completion of pleadings and further proceedings on 25th August, 2023.

CS(OS) 372/2020 & I.A.No.10975/2020 (by plaintiff u/O XXXIX Rule 1 & 2 CPC)



1. As per office noting, nothing fresh has been filed.
2. Written statement and affidavit of admission/denial of documents already filed on behalf of defendant no.2.
3. No replication and affidavit of admission/denial has been filed on behalf of plaintiff qua defendant no.2. Time sought. Let the same be filed as per law.
4. An application for bringing on record LR's of defendant no.3 is pending for consideration.
5. No fresh address of defendant no.1 has been filed on behalf of the plaintiff.
6. On filing of fresh address of defendant no.1, issue fresh summons of suit and notice of the pending applications to the defendant no.1 through all permissible modes for next date of hearing.
7. No written statement and affidavit of admission/denial of documents has not been filed on behalf of the defendants no.4 and 5.
8. Ld. Counsels for plaintiff and defendant no.2 submit that talks of settlement are still going on. Adjournment sought. Heard, allowed.
9. Let the pleadings be completed as per law.
10. Re-notify the matter for further proceedings on 25th August, 2023.
