1. This hearing has been done through hybrid mode.
2. These are four appeals filed by the Appellants *i.e.*, Suresh Kr. Aggarwal, Shyama Devi, Pradeep Aggarwal and Shiv Kumar seeking setting aside the order of conviction dated 6th April, 2020 and order of sentence dated 20th May, 2024 passed by the ASJ, New Delhi. *Vide* the above stated orders, the Appellants- Suresh Kr. Aggarwal, Shyama Devi, Pradeep Aggarwal have been convicted under sections 498-A/302/34 IPC and Shiv Kumar (uncle-in-law of the deceased) was convicted under section 302/34 IPC.
3. The submissions have been commenced in the applications for suspension of sentence.
4. The status report along with the verification of the medical records of



Suresh Kr. Aggarwal(father in law of the deceased) has been placed before the Court today. The same is taken on record. The interim bail granted to Suresh Kr. Aggarwal *vide* the last order dated 25th July, 2024 is extended till the next date of hearing.

5. In addition, the State shall also produce the original case diary relating to the present cases maintained by the IO, in order to see whether any specific statement of the deceased was recorded by the IO.
6. List for further hearing on 21st August, 2024.
