1. This hearing has been done through hybrid mode.
2. The present Appeals are part heard.
3. Adjournment is sought on the ground of bereavement in the family of the main counsel for the Appellants - Mr. Siddharth Yadav. It is submitted on behalf of Mr. Siddharth Yadav, Id. Counsel that earlier he was only representing Appellant in **Crl.A. 525/2024 i.e.,** Shiv Kumar. However, he has also been recently engaged by other Appellants in remaining appeals.
