**IA No.22536/2026 (filed on behalf of plaintiffs seeking modification / clarification of order dated 31.07.2026)**

1. The applicant seeks clarification *qua* the following para-5 of the order dated 31.07.2026:

*“5. The next date of hearing before the learned Joint Registrar (Judicial) shall be deferred till after the said date.”*

2. Considering the averments made in the application and having heard respective counsel, it is clarified that the hearing before the learned Joint



Registrar (Judicial) on 25.08.2026 shall proceed, as scheduled.

3. The recordal of evidence of PW1 shall be undertaken on that day as per the previous direction of the Joint Registrar (Judicial).

4. Application is disposed of in the above terms.

**CS(OS) 381/2020, IA No.14742/2026, IA No. 14741/2026 & IA No. 11847/2022**

5. With the consent of parties, the following order is passed:

(i) IA No. 11847/2022 (filed under Order I Rule 10, on behalf of defendant for deleting the name of the defendant from the array of parties to the present suit) stands dismissed as withdrawn.

(ii) IA No. 14741/2026 (under Order I Rule 10(2) for impleadment of defendant) is allowed. The applicant is impleaded as defendant no.2.

(iii) It is agreed that the newly impleaded defendant shall adopt the written statement already filed by defendant no.1. No fresh documents / pleadings are required to be filed nor any fresh issues are required to be framed.

(iv) The newly impleaded defendant shall be entitled to file its affidavit of evidence; needless to say, the said affidavit shall be on the basis of the pleadings. The said defendant would be at liberty to adduce such other evidence / produce witnesses as may be admissible under law.

(v) IA No.14742/2026 (filed on behalf of applicant Kapil Sharma u/O XXXIX R 1&2, seeking stay of proceedings / evidence of plaintiffs in suit) is dismissed as withdrawn.

6. As already directed, the hearing scheduled before the Joint Registrar



(Judicial) on 25.08.2026 shall proceed, as scheduled, for continuation of cross-examination of PW1.

7. The date already fixed i.e. 05.10.2026 stands cancelled.
