I.A. No. 200/2025 filed by defendant no. 1 for condonation of delay of 26 days in filing affidavit giving details of the revenue generated/monetization detail from the infringing content of the plaintiffs from 1st April'2022 to 30th September'2024.

1. Issue notice. Notice accepted by Id. Counsel for the plaintiff who submits that if the delay is to be condoned, same should be subject to a reasonable cost.
2. For the reasons stated in the application, application is allowed subject to cost of Rs. 500/-, to be deposited with Delhi
