I.A. 32525/2024

1. Defendant No. 1 and the parties to I.A. 32525/2024 are directed to ensure that an affidavit in compliance with order dated 08.07.2024 (paragraph 8) is filed within two (2) weeks, failing which, coercive orders shall be issued against the said parties.

Exemption to Defendant Nos. 2 and 3

2. Defendant Nos. 2 and 3 are exempted from further appearance at this stage. In case, the presence of Defendant Nos. 2 and 3 is required, notice shall be issued through counsel, who had entered appearance.

Order dated 29.05.2025

3. This Court has put a query to Defendant No. 1 if it has complied with directions issued at paragraph '9' of the order dated 29.05.2025.

4. Learned Senior counsel appearing on behalf of Defendant No. 1 states that an appeal was preferred against order dated 29.05.2025, which has been disposed of by the Division Bench on 13.08.2025 and in view of the said order, the Defendant No. 1 has elected not to comply with the direction of deposit of USD 30,000/- issued vide order dated 29.05.2025. He states that the order dated 13.08.2025 is not available.

5. This issue will be considered after perusing the order dated 13.08.2025.

Take down of infringing content

6. Learned counsel for the Plaintiffs has handed over a list comprising of four (4) songs to the Court and Defendant No. 1, which have been unauthorizedly uploaded on BOOMPLAY.

7. The list of infringing content is set out hereinbelow:

8. Learned Senior Counsel for Defendant No. 1 states on instructions that this infringing content will be taken down within 48 hours.

9. Learned counsel for the Plaintiffs points out that the song enlisted at Serial No. 3 was earlier directed to be taken down vide order dated 27.05.2024 and therefore, its re-uploading/availability is in gross violation of the order dated 27.05.2024.

10. The authorized representative of Defendant No. 1 is directed to file an affidavit (no. 1) within three (3) weeks explaining the re-uploading/availability of song enlisted at Serial No. 3 inspite of the take down order 27.05.2024. The authorized representative will also remain present (through VC link) on the next date of hearing.

11. In addition, Defendant No. 1 is directed to file an updated affidavit (no. 2) of the action taken for removing the Plaintiffs' copyrighted songs w.e.f. 01.12.2024 until 14.08.2025. Let the affidavit be filed within three (3) weeks.

Defendant No. 1 will also file an updated affidavit (no. 3) of the action taken for removing the Plaintiffs' copyrighted songs w.e.f. 14.08.2025 until 15.10.2025, one week prior to the next date of hearing.
