1. It is submitted that the captioned IA is coming up for
hearing before the Hon'ble Court on 23.03.2026.

2. The present matter is at the stage of admission/denial of
documents.

3. Ld. Counsel for defendant no. 1 submits that the plaintiff
has not filed the fresh Joint Document Schedule in terms
of order dated 02.12.2024.

4. Ld. Counsel for plaintiff submits that on 02.12.2024, he



pointed out certain columns in the Joint Document Schedule has been left blank by defendant nos. 2 to 5. Therefore, he had sought permission to file afresh joint document schedule.

5. Those blank columns were filed by defendant no. 2 to 5 later on and he re-filed the same Joint Document Schedule after changing the date therein.
6. On 28.02.2025, it has been recorded that soft as well as hard copy of Joint Document Schedule has been filed. Therefore, I find no merits and contentions of defendant no. 1 that plaintiff has failed to file afresh joint document schedule in terms of order dated 02.12.2024.
7. Ld. Counsel for defendant no.1 further submits that plaintiff has filed certain documents alongwith the reply in I.A 39845/2025 and the said IA is still pending.
8. Ld. Counsel for plaintiff submits that he is not relying upon those documents at this stage in the suit. Those documents are subject to outcome of I.A.39845/2025.
9. Defendants are directed to appear in person for admission/denial of documents on next date of hearing otherwise cohesive steps shall be taken.
10. Re-notify the matter for admission/denial of documents and further proceedings on **27th March, 2026**.
