1. This Court had on 19.03.2024 directed the Respondents to file a Short-Affidavit as to whether the post of the Petitioner was recreated/reintroduced and the manner in which it was filled up. On 21.08.2024, the Respondents took additional time to file the same. The compliance of the order has still not been done by the Respondents despite the opportunities given.
2. Learned Counsel for the Respondent/DOE seeks more time to comply with the orders.
  - 2.1 Let the compliance be done within one week, failing which the Affidavit shall be taken on record subject to payment of costs in the sum of Rs. 5,000/- in each matter, payable to the Petitioner. Proof of costs shall be attached with the Affidavits, if delayed.
3. The Affidavit has been filed by the Respondent No.2/School in W.P.(C) 1767/2007. However, the Respondent No.2/School has not filed the Affidavit in remaining matters.
4. None appears for the Respondent No.2/School either.



4.1 Let the necessary affidavit be filed by Respondent No.2/School within one week.

5. Learned Counsel for Respondent No.3/GNCTD of Delhi on instructions submits that he does not wish to file any Affidavit.

6. The Written Submissions as was directed by the Court on 07.03.2023 have been filed by the Petitioner. The Petitioner also draws the attention of the Court to order dated 07.11.2023 where the directions were passed and it was made clear that no adjournment shall be granted in the matters. This order has also not been complied with by either of the Respondent.

7. Mr. Anuj Aggarwal, Adv. [Mobile No. 9891403206 & Email:anujaggarwalcompany@gmail.com] is appointed as *amicus curiae* to assist the Court. The Petitioner shall cooperate with the *amicus curiae* appointed by this Court.

7.1 Registry is directed to provide a complete set of paper book to him within three days.

8. List the matters for hearing and final disposal on 21.11.2024 at 4 PM.
