1. Exemption is allowed, subject to all just exceptions.
2. The Application stands disposed of.

3. Let the Plaint be registered as a Suit.
4. Issue Summons to the Defendant. The learned Counsel for the Defendant accepts Summons.
5. The Defendant shall file the Written Statement within 30 days from



the date. Along with the Written Statement, the Defendant shall also file an Affidavit of Admission / Denial of the documents of the Plaintiffs, without which the Written Statement shall not be taken on record.

6. Liberty is granted to the Plaintiffs to file Replication, if any, within thirty days from the receipt of the Written Statement. Along with the Replication filed by the Plaintiffs, Affidavit of Admission / Denial of the documents of Defendant be filed by the Plaintiffs, without which the Replication shall not be taken on record.

7. In case any Party is placing reliance on a document, which is not in their power and possession, its details and source shall be mentioned in the list of reliance, which shall also be filed with the pleadings.

8. If any of the Parties wish to seek inspection of any documents, the same shall be sought and given within the prescribed timelines.

9. List before the Joint Registrar on 10.10.2025 for completion of pleadings and Admission / Denial of the documents.

10. Issue Notice. The learned Counsel for the Defendant accepts Notice.

11. Let the Reply be filed within a period of three weeks from date. Rejoinder thereto, if any, be filed within a period of one week thereafter.
