5. Ld. Counsel for plaintiff submits that no document has been filed on behalf of the defendant no.2, therefore, no affidavit of admission/denial of documents is required to be filed by the plaintiff qua defendant no.2.
6. Let the pleadings be completed as per law.
7. Re-notify the matter for completion of pleadings and further proceedings on **13th September, 2023**.
