Matter is taken up through physical hearing as well as video conferencing.

Ld. Counsel for plaintiff states that they do not wish to file Replication to the Written Statement of defendant no.11 to 16.

Ld. Counsel for defendant no. 3,4 and 5 submit that after he has removed objection from the Written Statement on 17.09.2025, he has re-filed the same on 26.09.2025, however there is no such noting in this regard. Ld. Counsel for defendant no. 3,4 and 5 is directed to check the same with the Registry and remove objections if any.

None is present on behalf of defendants no. 17 to 19. Neither any Written Statement has been filed on their behalf nor any advance copy has been supplied to plaintiff. The time to file Written Statement by defendant no. 17 to 19 already stands lapsed. Therefore, right of defendants no. 17 to



19 to file Written Statement stands closed and defendants no. 17 to 19 are also proceeded ex-parte.

None is present on behalf of defendants no. 1 and 2 also Defendants no. 1 and 2 were served on 02.08.2025, however no Written Statement has been filed on their behalf, nor any advance copy has been supplied to plaintiff. The time to file Written Statement by defendant no. 17 to 19 already stands lapsed. Therefore, right of defendants no. 1 and 2 to file Written Statement stands closed and defendants no. 1 and 2 are also proceeded ex-parte.

The service report qua defendants no. 6 to 10 is still awaited. Let in these circumstances, defendants no. 6 to 10 be served afresh on filing of PF, by all permissible modes. Dasti summons also allowed as prayed for.

Ld. Counsel for defendant no. 3,4 and 5 shall also be supplying the copy of Written Statement alongwith affidavit of admission/denial to Ld. Counsel for plaintiff.
