1. It is submitted that the captioned IAs are coming up for hearing before the Hon'ble Court on 06.09.2022.

Counsels appearing for the parties state that Mr. Siddhant Nath had appeared on behalf of defendant no.2 on last date of hearing. In view of submissions of Ld. Counsels for the parties, order sheet dated 23.08.2022 be read accordingly.
2. Joint Document Schedule and hard copies of documents not filed.
3. Ld. Counsel for plaintiff submits that he had shared Joint Document Schedule with Ld. Counsel for defendants, but Ld. Counsel for defendants no.1 and 2 refused to sign the same stating that the documents filed alongwith replication on behalf of the plaintiff could not have been come on record.
4. Ld. Counsel for defendant no.2 states that he had moved an application for taking off the said documents filed alongwith the replication from record. However, the same does not find mention in the office noting. Let appropriate steps be taken in this regard.

6. Let the matter be placed before the Hon'ble Court for further directions on date already fixed i.e. **06th September, 2022.**
