1. Though office report indicates that respondent No. 3 is unserved, an affidavit of service dated 29.04.2024 shows that respondent No. 3 has been served.

2. Perusal of the Process Server's report shows that the address mentioned of the respondent No. 3 i.e. Riyasat Farm, Main Mandi Road, Sultanpur, New Delhi has been demolished. However, the Process Server has reported that on finding the premises demolished,

3. Learned counsel for the appellant submits that respondent No. 3 has mentioned the same address as the registered address in several litigations filed by him. He further submits that copy of the appeal paper book as well as summons were served upon Mr. Deepender Singh through WhatsApp as well as e-mail and the e-mail has not bounced back.

4. Perusal of the affidavit of service as well as the Process Server's report clearly indicates that Mr. Deepender Singh has been duly intimated about the pendency of the present proceedings and is accordingly deemed to have been served.

5. The office report further indicates that service with regard to respondent No. 16, i.e. Rama Packaging is awaited. However, Ms. Varnika Sharma, Advocate has entered appearance for respondent No. 16. Accordingly, respondent No. 16 is also deemed served. Service is accordingly complete.
