Valuation report has not been filed by respondent no.1. But the status report has been filed by the concerned SDM Kalkaji that despite notice to the petitioner, he did not provide the documents of the property for preparing valuation report, due to which report could not be filed.

The petitioner is directed to cooperate with the concerned official of the SDM office for preparation of the valuation report. Fresh reminders be issued to the concerned SDM for filing valuation report.

At request of the petitioner, fresh court notice be issued to the concerned Bank Managers of the banks as mentioned in the Schedule 'B' for filing of accounts statements of bank accounts and FDRs mentioned in the Schedule 'B'.

Learned counsel for LR No.2 has stated that LR no.2 is not in possession of the title documents and is also not in possession of the suit property. She has further stated that she had filed objections/reply in December, 2021, but it is not on record. Learned counsel for LR No.2 is directed to check with the Registry and to get the objections/reply placed on record within one week.
