Vide these applications, under Order XXII Rule 4 read with Section 151 of the Code of Civil Procedure, 1908, the Applicant/Respondent No.5 seeks directions to take on record the Memorandum of Family Settlement dated 12.03.2025 executed between the parties and in view of that to substitute the deceased Respondent No.1, Ms. Sita Chaudhary, with her legal representatives, namely: (1) Mr. Deepinder Singh, (2) Mr. Verinder Singh, (3) Mr. Bhupen Phougaat, (4) Ms. Shruti Manav Sharma, (5) Mr. Arjun Singh and (6) Ms. Kritika Phougaat.

2. Issue notice.

3. Learned counsel for the Appellants accept notice and submit that they have no objection if the substitution of the deceased Respondent No.1 with the afore-named persons is allowed, however, the same should be subject to rights & contentions of the Appellants, against them which could be raised during the final arguments.

4. In view of the aforesaid, the applications are allowed. The Memorandum of Family Settlement dated 12.03.2025 is taken on record. The deceased Respondent No.1, Ms. Sita Chaudhary, shall stand substituted by her legal representatives, namely, (1) Mr. Deepinder Singh, (2) Mr. Verinder Singh, (3) Mr. Bhupen Phougaat, (4) Ms. Shruti Manav Sharma, (5) Mr. Arjun Singh and (6) Ms. Kritika Phougaat.

5. It is made clear that the aforesaid substitution is allowed only for the purpose of permitting the legal representatives of Respondent



No.1 to defend the appeal.

6. Applications stand disposed of accordingly.

7. Let the amended memo of parties be filed within one week.
