1. It is submitted that the captioned IAs are coming up for hearing before the Hon'ble Court on 22.02.2023.

1. It is submitted that the captioned IA is coming up for hearing before the Hon'ble Court on 22.02.2023.
2. As per office noting for 20.10.2022, Separate replies to the captioned IA were filed on behalf of defendant no.1 and on behalf of defendants no.3 & 4.
3. The plaintiff may file rejoinder to the above said replies within four weeks as last opportunity with advance copy to the opposite party.
4. Last opportunity is granted to the defendant no.2 for filing reply to the captioned IA to be filed within four



weeks with advance copy to the opposite party, who may file rejoinder within two weeks thereafter.

5. Re-notify the captioned IA for completion of pleadings and further proceedings on **17th February, 2023**.

CS(OS) 531/2022

1. It is submitted that the matter is coming up for hearing before the Hon'ble Court on 22.02.2023.
2. As per office noting for today, vakalatnama filed on behalf of defendant no.2 on 18.11.2022.
3. Office noting for 20.10.2022 would show that separate written statements and affidavit of admission/denial of documents were filed on behalf of defendant no.1 and on behalf of defendants no.3 & 4 on 13.10.2022.
4. The said office noting for 20.10.2022 would further show that separate vakalatnamas and documents were also filed on behalf of defendant no.1 and on behalf of defendants no.3 & 4 on 14.10.2022.
5. No replication and affidavit of admission/denial has been filed on behalf of the plaintiff qua defendants no.1, 3 & 4.
6. Office noting for 20.10.2022 would show that documents were filed on behalf of the plaintiff on 22.09.2022 and affidavit of compliance was also filed on behalf of the plaintiff on 07.09.2022.
7. No written statement has been filed on behalf of the defendant no.2 till date.
8. The defendant no.2 may file written statement and affidavit of admission/denial as per law with advance copy to the opposite party, who may file replication and affidavit of admission/denial thereafter as per law.
9. Today, the matter is also fixed for producing document in



compliance of order dated 20.10.2022 on the submissions of Ld. Counsel for defendants no.1, 3 and 4 made on 18.11.2022.

10.Ld. Counsel for defendants no.1, 3 and 4 has submitted that in view of order dated 20.10.2022 passed by Hon'ble Court in IA No.17385/2022, the above said defendants have brought two original Wills and original Gift Deeds alongwith their hand writing expert with voice recording and video recording of Smt. Mahender Kaur. He has further submitted that the plaintiff was directed to offer inspection of the original Will dated 09.09.1993 and Will dated 28.12.2020 executed by Late Sh. Sewa Singh and Late Smt. Mahender Kaur, respectively, to the defendant no.1.

11.Ld. Counsel for defendants no.1, 3 and 4 submits that he has brought their experts namely Mr. Deepak Jain, Handwriting Expert and Dr. Ranjeet Singh & Mr. Ankit Tripathi.

12.On 18.11.2022, both the parties had submitted that they will produce documents in compliance of order dated 20.10.2022 today at 12.30 p.m.

13.There is no appearance on behalf of the plaintiff despite repeated calls from 12.30 p.m. till now i.e. 02:22 p.m.

14.Ld. Counsel for defendants no.1, 3 and 4 has submitted that he will avail his remedies as per law.

15.Re-notify the present matter for further proceedings on **17th February, 2023.**
