1. It is submitted that the matter is coming up before this Court on 30.03.2026.
2. File is taken up on listing of the below mentioned IAs.

I.A.No.5470/2026 (under Order I Rule 10 r/w Section 151 CPC filed on behalf of the plaintiff seeking impleadment of LRs of deceased defendant no.1) &

I.A.No.5471/2026 (under Order I Rule 10 r/w Section 151 CPC filed on behalf of the plaintiff seeking impleadment of LRs of deceased defendant no.8)



3. As per office note, service report qua LR's of Defendant No. 1 and Defendant No. 8 is awaited.
4. Learned counsel appears through VC on behalf of the LR's of Defendant No. 1. Notice is issued and accepted by learned counsel. Accordingly, formal issuance of notice is waived. Let the reply, if any, be filed within four weeks from today, with rejoinder, if any, within two weeks thereafter.
5. The plaintiff is directed to take fresh steps for service of notice upon LR's of Defendant No. 8 within one week from today.
6. As per office note, Defendant Nos. 3 and 4 have been served on 19.03.2026, whereas service report qua Defendant Nos. 2 and 5 to 7 is awaited. Let fresh notice be issued to Defendant Nos. 2 and 5 to 7 on taking steps within one week from today through all permissible modes.
7. As per office note, Defendant No. 11 could not be served as the address was incomplete and did not mention the block number. Learned counsel for Defendant Nos. 9 and 10 submits that the correct address includes Block 'N'.
8. The plaintiff is directed to make necessary corrections in the memo of parties and file the amended memo at least two weeks prior to the next date of hearing.

9. As per office note, the written statement filed on behalf of Defendant Nos. 3 and 4 is under objections. Defendant Nos. 3 and 4 are directed to coordinate with



the Registry, remove the objections, and ensure the same is placed on record.

10. The matter was earlier listed on 30.03.2026. However, in view of the directions issued for fresh service upon LRs of deceased Defendant No. 8 in IA No. 5471/2026, which would require time, no effective proceedings can take place on the said date.

11. Accordingly, the date of hearing i.e., 30.03.2026 stands cancelled, and the matter is re-listed for 23.07.2026.
