**I.A. No. 7071/2024 (moved by D-3 u/S 8 of Arbitration &
Conciliation Act)**

1. As per office noting, reply to the captioned IA has been filed on behalf of the plaintiff. No rejoinder to the said reply has been filed by defendant no.3. Time sought. Let the same be filed within four weeks.
2. Ld. Counsel for defendant no.1 submits that she does not



wish to file any reply to the captioned IA and has no objection if the same is allowed.

I.A. No. 6889/2024 (by D-3 for condonation of delay in filing WS)

3. Ld. Counsel for plaintiff submits that he does not wish to file any reply to the captioned IA and has no objection if the same is allowed.
4. Heard. For the reasons stated in the application and in view of the above submissions, delay in filing written statement by defendant no.3 is condoned and the same be taken on record if complete in other respects.
5. The captioned IA stands disposed off accordingly.

I.A. No. 11598/2019 (by plaintiff for stay)

6. Perusal of record shows that separate replies to captioned IA has been filed on behalf of the defendant no.1 and defendant no.2. No rejoinder to the said replies has been filed on behalf of the plaintiff. Time sought. Let the same be filed within four weeks as last opportunity.
7. No reply to the captioned IA has been filed on behalf of defendant no.3. Time sought. Let the same be filed within four weeks as last opportunity and rejoinder thereto be filed within two weeks thereafter.

8. Perusal of record shows that separate written statements, affidavits of admission/denial of documents and list of documents with documents were already filed on behalf of defendant no.1 and defendant no.2.
9. Perusal of record further shows that separate replications alongwith affidavits of admission/denial of documents were already filed on behalf of plaintiff qua defendant no.1 and defendant no.2.



10. Perusal of record further indicates that written statement and affidavit of admission/denial of documents were filed on behalf of defendant no.3 vide diary no.820815/2024. The same be taken on record in terms of order passed today in IA No.6889/2024.
11. The plaintiff may file replication alongwith affidavit of admission/denial of documents qua defendant no.3 as per law.
12. It is submitted that application u/S 8 of Arbitration & Conciliation Act on behalf of the defendant no.3 is also pending for consideration.
13. Let the pleadings be completed as per law.
14. Re-notify the present matter for completion of pleadings and further proceedings on **22nd January, 2025**.
