1. Issue notice to the respondents.
2. On behalf of respondent nos. 1 and 2, learned counsel has put in appearance and accepts notice, whereas learned counsel appearing for respondent no.3 also accepts notice.
3. Let counter affidavit be filed by the respondents 1 & 2 within eight weeks. Two weeks thereafter shall be available to the petitioners to file the rejoinder affidavit, if any.
4. List on 18.09.2025.
5. In the meantime, we direct the respondent nos. 1 and 2 to permit the petitioners to submit by 31st May, 2025 their respective applications under Section 14/15 of the NCTE Act, 1993 seeking recognition for Integrated Teacher Education Program (ITEP) for academic session 2026-2027 along with the requisite fee. However, no final decision on the said applications shall be taken till this petition is finally decided. We further provide that the petitioners shall not claim any equities on the ground that they were permitted to submit the applications; neither shall they seek refund of the fee for processing the applications under any circumstances.
6. In **W.P.(C.) No.7599/2025**, learned counsel for the petitioner prays that in the memo of the parties, name of the petitioner has wrongly been described on account of an inadvertent mistake i.e. in place of SKS College, SAS College has been inscribed. He thus prays that he may be permitted to incorporate the said correction in the amended memo of parties.



7. The prayer made by the learned counsel for the petitioner is allowed. The amended memo of the parties shall be filed by the petitioner within a week.
8. Registry is directed to reflect the correct name of the petitioner whenever the matter is next listed.
