The defendant no. 4, 11, 13, 16 & 17 were yet to be served as per last order.

Fresh vakalatnama has been filed by defendant no. 17, vide diary no. 7396978/2025. Same be taken on record.

Ld. counsel for the no. 17 submitted that she received only the summons from the PSA Branch on 27.09.2025 without any paper-book. The plaintiff is directed to supply the same to defendant no. 17 within a week.
