Ld. counsel for the plaintiff submits that he will supply the paper-book to ld. counsel for the defendant no. 17 today itself. Submissions be taken on record, thereafter written statement be filed as per law.

Ld. counsel for the plaintiff submits that defendant no. 4, 11, 13, 16 may be served afresh. Submissions be taken on record. Issue fresh summon to defendant no. 4, 11, 13 & 16 through all permissible modes, subject to the filing of PF.
