1. Pleadings are complete.

2. The matter is at the stage of admission/denial of
documents. As per office note, cost proof filed by the
plaintiff.

3. Joint document schedule has not been filed. Learned
counsel for defendant nos. 1 & 2 submits that a proper
joint document schedule has not been prepared by the
plaintiff. Necessary corrections be made in the joint



document schedule and the draft joint document schedule be sent to learned counsels for defendants within a week who shall return the same to learned counsel for plaintiff within fifteen days thereafter with their comments thereon.

4. Joint document schedule along with its hard copy be filed at least a week prior to the date to be fixed before this court. Hard copy of the documents, which are e-filed, be filed within four weeks. Parties shall produce the original documents on the date to be fixed before this court.

5. Vide order dated 21.05.2024, the Hon'ble Court had observed that the record of Civil Suit bearing CS (DJ) No. 66/2020 titled as 'Charanjeet Gulati Vs. Inder Kumar Gulati' be called for, be scanned and tagged along with the records of the present suit. The suit had to be separately listed and adjudicated along with the present suit.

6. The record of Civil Suit bearing CS (DJ) No. 66/2020 titled as 'Charanjeet Gulati Vs. Inder Kumar Gulati' has not been tagged with the present suit nor it is listed separately today. Registry shall comply with the order of the Hon'ble Court dated 21.05.2024.

7. Learned counsels for parties submit that the matter is listed before the Hon'ble Court on 26.07.2024. The file may be placed before the Hon'ble Court on date already fixed i.e. 26.07.2024 for further directions.
