1. This petition has been filed alleging wilful disobedience of order dated 4th April 2024 passed by the ACJ, South West Delhi, where an undertaking was recorded in **CS SCJ 82/2024** that defendant (*respondent herein*) would not file any fresh complaint, to any authority, against the plaintiff.

3. Accordingly, issue Notice to respondent on steps being taken by petitioner through all permissible modes including E-mail, etc.
4. Counsel for petitioner seeks liberty to file additional documents. The same may be done before the next date of hearing.
5. He also points out to a connected matter i.e. **CONT.CAS(C) 336/2025**, in which, orders were passed on 5th March 2025, where the petition was dismissed as withdrawn, with liberty to petitioner to approach the Court if respondent indulges in continuous disobedience of directions of the Civil Judge.
6. Counsel for petitioner says that despite various orders and injunctions passed by the Civil Judge, respondent continues to violate the same.
