1. Learned counsel appearing for the petitioner draws the attention of this Court to the order dated 25th March, 2026, passed by this Court, wherein, directions were issued to the respondents to undertake fresh demarcation exercise to clearly identify *Khasra Nos. 623 and 624, Revenue Estate of Village Maidan Garhi, Tehsil Mehrauli, New Delhi*, since it was the contention on behalf of the respondents that demolition action was taken in *Khasra No. 624*, and that the petitioner's premises was within the same.
2. On the other hand, it is the case of the petitioner that the petitioner's premises fall within *Khasra No. 623*.
3. Learned counsel appearing for the Government of NCT of Delhi ("GNCTD") submits that a fresh demarcation shall be carried out at the earliest, and a report shall be filed.
4. Accordingly, let the needful be done, within a period of four weeks.
5. Let fresh Demarcation Report, along with the affidavit be filed by the respondents, within a period of six weeks.
6. At the time of carrying out demarcation, the petitioner shall be informed through the petitioner's counsel, on the E-mail, which is reflected in today's order.
