1. Issue notice.
2. Learned counsel for defendant no. 1 accepts notice and submits that he has not received the copy of the captioned IA. He further submits that he has no objection if the fresh address of LR no. (v) & (vi) of plaintiff and defendant no.7 be taken on record.
3. Considering the submission, the fresh address of LRs no. (v) & (vi) of plaintiff and the fresh address of defendant no.7 as mentioned in the captioned IA is taken on record.
4. Plaintiff/ LR are directed to file amended memo of parties.
5. The captioned IA is disposed off accordingly.

Learned counsel for defendant no. 1 submits that in para no. 3 of the captioned IA, It has been averred one Ms. Shalini Tandon who was daughter of deceased plaintiff had been adopted by elder cousin brother of deceased plaintiff within few of her birth. However, no adoption paper is not place don record
9. Plaintiff is directed to file the adoption deed of Ms. Shalini Tandon as well as her current address on record within two weeks.
10. Issue fresh notice of the captioned IA to the LR no. (v) & (vi) of plaintiff and defendant no. 7 and Ms. Shalini Tandon through all permissible modes.
11. Reply be filed within four weeks. Rejoinder thereto, if any, be filed within two weeks thereafter.
