1. All these writ petitions concern service disputes and are directed against different electricity distribution companies, which have been privatised.

2. Learned counsel for the petitioners rely upon the judgments of a Coordinate Bench of this Court dated 03.10.2023 in W.P.(C) 14408/2022 [*Manjeet Kumar vs. Tata Power Delhi Distribution Limited & Ors.*], 12.10.2023 in W.P.(C) 523/2019 [*Yashpal Sharma vs. Tata Power Delhi Distribution Limited & Ors.*], and 13.10.2023 in W.P.(C) 13560/2023 [*Netrapal vs. Tata Power Delhi Distribution Limited*], to submit that writ petitions against electricity distribution companies are not maintainable, after privatisation of the entity in question.



3. Learned counsel for the petitioners submit that the view of the learned Single Judge in the said judgments is pending in appeals [LPA 56/2024 & LPA 184/2024], which are scheduled to be listed before the Division Bench on 24.04.2025.
4. These petitions have also been adjourned from time to time to await the judgment of the Division Bench.
