Pleadings in the suit are already complete.

Learned counsel for the plaintiff submits that she has already shared draft of Joint Schedule of the documents with counsel for the defendants on 20.09.2024. The copy of the relevant Email is shown and taken on record. Despite the order dated 12.09.2024, no inputs to Draft of Joint Document Schedule have been furnished by Counsel for D-1 and Counsel for D-2 to 4& LR's of D-5. So cost of Rs. 3000 each is imposed on Counsel for D-1 and Counsel for D-2 to 4& LR's of D-5. At this stage the learned counsel for D-1 has shared the e-mail sent by him giving his inputs to learned counsel for the plaintiff on 23.10.2024. So order for imposing cost on D-1 is recalled.
