1. Ld. Counsel for LR no.(i) to (iii) of defendant no.5 seeks time for filing reply to the captioned IA.
2. Let reply to the captioned IA be filed within four weeks with advance copy to the opposite party, who may file rejoinder within two weeks thereafter.
3. Re-notify the present matter for completion of pleadings and further proceedings on **24th March, 2023.**

1. As per office noting, written statement filed vide diary no.1852004 dt. 03.11.2022 was returned under objection.
2. Ld. Counsel for LR of defendant no.5 has submitted that written statement vide above said diary no.1852004 was filed on behalf of LR of defendant no.5 and he will take appropriate steps for removal of defects. Let appropriate steps be taken as per law.
3. Office noting further reveals that IA filed vide diary no. 1852007 dated 03.11.2022 was returned under objection. Let needful in this regard be done.
4. Written statement and affidavit of admission/denial of documents already filed on behalf of the defendant no.1.
5. Written statement and affidavit of admission/denial of documents already filed on behalf of the defendants no.2 to 4.
6. Ld. Counsel for plaintiff submits that replication and affidavit of admission/denial of documents qua defendant no.1 filed on behalf of plaintiff vide diary no.1063367 dated 30.07.2022 was not reflecting under objection. However, the same is still not on record. Let the needful in this regard be done. Let report be also called from Registry for next date of hearing.
7. No separate reply to the captioned IA filed on behalf of defendant no.1 and he adopted his written statement as reply to the captioned IA.
8. Ld. Counsel for the defendants no.2(i), 3 & 4 already submitted that the said defendants do not want to file any reply to the captioned IA.
9. Ld. Counsel for plaintiff submits that he has already filed affidavit of admission/denial of defendants qua defendant



no.1 alongwith replication. He further submits that no document was filed on behalf of defendants no.2 to 4, therefore, affidavit of admission/denial of documents qua defendants no.2 to 4 is not required to be filed.

10. Let the Joint Document Schedule, including hard copy of the same and hard copy of the documents, be filed by the parties at least two weeks before the next date.

11. Re-notify the present matter for completion of pleadings and admission/denial of the documents on **24th March, 2023.**
