To admit the present revision petition and to issue notice to the respondent and to call/summon for the trial court record of the present case FIR No. 154/2018, P.S.- Sultanpuri, Delhi, titled as State of Delhi vs. Puran Chand & Ors., from the court of Ms. Ruchika Singla, Ld. ASJ, Rohini Courts, Delhi and the same is pending for Dt. 21.12.2021 for P.E.

b. To set aside/quash impugned order dt. 04.09.2021 on the point of charge in FIR No. 154/2018, P.S.- Sultanpuri, Delhi.

c. To set aside/quash impugned order dt. 09.09.2021 of framing of charge U/s. 307/34 IPC, upon petitioner no. 1, passed by Ms. Ruchika Singla, A.S.J., north-west, Rohini Courts, Delhi in case FIR no. 154/2018, p.s.: Sultanpuri, Delhi.

AND/OR

d. To set aside/quash impugned order dt. 09.09.2021 of framing of charge u/s 376/307/34 IPC, upon petitioner no. 2, passed by Ms. Ruchika Singla, A.S.J., North-West, Rohini Courts, Delhi in case FIR no. 154/2018, P.S.: Sultanpuri, Delhi.

AND/OR

e. To set aside/quash impugned order dt. 09.09.2021 of framing of charge u/s 354/307/34 IPC & 10 POCSO act, upon petitioner no. 3, passed by Ms. Ruchika Singla, A.S.J., North-West, Rohini Courts, Delhi in case FIR no. 154/2018, P.s.: Sultanpuri, Delhi.

AND/OR

f. Discharge the petitioners in the present case FIR No. 154/2018, P.S.-Sultanpuri, Delhi.

AND/OR

g. Quash the FIR No. 154/2018, P.S.- Sultanpuri, Delhi and its subsequent processing pending before the Hon'ble Court of Ms. Ruchika Singla, ASJ, North-West, Rohini Courts, Delhi, against the petitioners.

AND/OR

h. Stay the trial-proceedings before the trial court of Ms. Ruchika Singla, A.S.J., North-West, Rohini Courts, Delhi, of the present case FIR, till the final disposal of the present revision petition, as the same has also been prayed vide annexed application U/S 482 Cr.P.C. before this Hon'ble Court, for seeking ad-interim ex-parte stay of the trial court proceedings.

AND/OR

i. Pass such other further order(s)/relief(s)/direction(s) as may be



deemed just and proper by considering the facts & circumstances of the present case so as to be the same in the interest of Justice as well as in the interest of petitioner.”

2. There is an application also for stay of the Trial Court proceedings.
3. Issue notice to the respondent.
- 3.1 It has been noticed that only State has been made as party. Let the complainant/victims be also impleaded as respondents, and thereafter, notice be issued to them on taking steps by the present petitioners.
- 3.2 Learned APP accepts notice on behalf of the State.
4. Let amended memo of parties be filed within one week from today.
5. List this matter before the concerned Joint Registrar on 20.05.2022 for service of the newly impleaded respondents.
6. List before Court on 17.08.2022.
