Crl.M.A.6012/2023 (for modification of order dated 02.03.2023)

1. Learned counsel for the appellant by way of the present application, seeks clarification of the order dated 02.03.2023 passed by this Court in Crl.M.(Bail) No.288/2023 to the extent that the petitioner may be granted permission to visit Rewa, Madhya Pradesh where the engagement of the son of the petitioner is to take place. The interim suspension of sentence with effect from 04.03.2023 to 18.03.2023 was granted only on the ground of engagement of the son of the petitioner.

2. Issue notice. Mr. Kartik Kaushal, learned counsel appearing on behalf of learned SPP for CBI accepts notice and submits that the appropriate directions may be passed.



3. In view of above, the order dated 02.03.2023 is modified to the extent that the petitioner may visit Rewa, Madhya Pradesh on 10th, 11th and 12th of March, 2023. However, on all the said dates, the appellant shall remain available on Mobile No.7275920742 and shall drop a PIN on the Google map to ensure that his location is available to the Investigating Officer. The appellant shall also report on all the said three dates to the local police station where the engagement is to take place.
4. Learned counsel for both the parties submit that that in para (iii) of the order dated 02.03.2023, inadvertently, the name of the Investigating Officer has been mentioned as SI Ravi in place of Inspector Ganesh Shanker. It has also been stated that there is an inadvertent error in the Mobile Number mentioned in para (iii). The correct mobile number is 9198920631.
5. Let these corrections be rectified.
6. Para 3 of the order dated 02.03.2023 shall read as under :-
“(iii) The appellant shall further remain in touch telephonically with Inspector Ganesh Shanker on mobile number i.e. 9198920631 on the first Monday of every month;”
7. Mr. Kartik Kaushal, learned counsel appearing on behalf of learned SPP for CBI submits that he is satisfied with the above conditions.
8. With these observations, the present application stands disposed of.
