1. As per office noting, service report of summons issued to the defendant no.2 through ordinary mode is awaited, however, summons have been served upon defendant no.2 through speed post.

5. Office noting further shows that replication alongwith affidavit of admission/denial of documents were filed on behalf of plaintiff qua defendant no.1.
6. Office noting also shows that additional documents with list of documents were also filed by the plaintiff vide diary no.135438/2024.
7. Ld. Counsel for defendant no.1 has submitted that he has not received copy of replication alongwith affidavit of admission/denial of documents and documents. Let the same be supplied within three days.
8. The defendants may file affidavit of admission/denial with respect to additional documents of plaintiff as per law.
9. Office noting also shows that reply to the captioned IA has been filed on behalf of defendant no.1. No rejoinder to the said reply has been filed by the plaintiff. Some time has been sought.
- 10.No written statement, affidavit of admission/denial of documents and reply to the captioned IA has been filed by the defendant no.2. Let the same be filed as per law.
