1. It is submitted that the captioned IA is coming up for hearing before the Hon'ble Court on 28.04.2025.

**I.A. No. 48932/2024 (by petitioner u/O I Rule 10 CPC for impleadment of ICICI Prudential Life Insurance Co. Ltd. as party to the petition)**

2. It was already submitted on behalf of respondents no.1 to 3 that the respondent no.1 did not wish to file any reply to the captioned IA and has no objection if the same is allowed.
3. As per office noting, notice of the captioned IA has been served upon respondent no.8.
4. It is submitted on behalf of respondents no.5, 8 and 9 that they do not wish to file any reply to the captioned IA and have no objection if the same is allowed.
5. No reply to the captioned IA has been filed on behalf of respondents no.4, 6 and 7. There is no appearance on behalf of the said respondents. Last opportunity is granted to the said respondents to file reply to the captioned IA within four weeks and rejoinder thereto be filed within two weeks thereafter.
6. Issue notice of the captioned IA to proposed respondent no.10 for next date of hearing, who may file reply to the captioned IA within four weeks from the date of service and rejoinder thereto be filed within two weeks thereafter.

7. As per office noting, citation in 'The Statesman' dated



05.04.2025 has been received from The Statesman Ltd. vide diary no.11333 dated 09.04.2025.

8. Citation in 'The Statesman' and 'Dainik Jagran' have also been filed on behalf of the petitioner.
9. Perusal of record shows that valuation report of Karol Bagh property mentioned at sr. no.16 of Schedule-I has been filed vide diary no.4115959/2024.
- 10.As per office noting, notice has been served upon SDM, Greater Noida, SDM Pargana Khurja and SDM, Pargana Jewar.
- 11.Office noting further reveals that one status report has been received from SDM, Khurja, Bulandshahar vide dairy no.3443/2025. However, the same does not give any reference of value of the property in question. Let fresh notice be issued to SDM, Khurja, Bulandshahar for filing valuation report specifying the valuation of the property in question.
- 12.Ld. Counsel for respondent no.1 has submitted that he has filed valuation report of property at Sainik Farm, Khirkee Extension, Delhi.
- 13.Issue fresh notice to concerned SDMs for filing valuation reports of properties at sr. no.2 to 15 of Schedule-I of the petition for next date of hearing.
- 14.Ld. Counsel for respondent no.9 has submitted that with the details provided to respondent no.9, no account was found in the concerned bank. He has further submitted that detailed report will be filed within four weeks from today. Let the same be filed accordingly.
- 15.Office noting reveals that reply to petition filed on behalf of respondents no.2 and 3 vide diary no.1010006/2025



was returned under objection. Let appropriate steps be taken as per law within three weeks.

16. Office noting further reveals that one reply filed on behalf of respondents no.2 and 3 vide diary no.1010066/2025 was returned under objection. Let appropriate steps be taken as per law within three weeks.

17. Ld. Counsel for respondent no.5 has submitted that she will file the requisite details during the course of the day. Let the same be filed accordingly.

18. No details have been provided by the respondents no.4 and 6 in terms of previous order. There is no appearance on behalf of the said respondents. Let court notice be issued to the said respondents through counsel as well as in person, without PF, for compliance of the previous order, returnable on next date of hearing.

19. As per office noting, court notice issued in terms of order dated 15.01.2025 has been served upon respondent no.8.

20. Let the pleadings be completed as per law.

21. Re-notify the matter for completion of pleadings and further proceedings on **25<sup>th</sup> July, 2025**.
