1. The present Petitions have been filed by the Petitioners/landlords impugning the Order dated 15.03.2023 [hereinafter referred to as the "Impugned Order"] passed by the SCJ-cum-RC, (Shahdara), Karkardooma Courts, Delhi. The present Petitions have been filed with respect to one shop having private no.2, in property bearing No.1/3216, Ram Nagar, Mandoli Road, Shahdara, Delhi-110032 in *RC.REV. 265/2023* and one shop bearing private no.3, in property bearing no.1/3216, Ram Nagar, Mandoli Road, Shahdara, Delhi-110032 in *RC.REV. 266/2023*. By the Impugned Order, the Trial Court has allowed the Applications for Leave to Defend filed by the Respondents/tenants.
2.
