1. No reply to the captioned IA has been filed on behalf of defendants despite last opportunity. Their right to file reply to the captioned IA stands closed.

2. As per office noting, written statement and affidavit of admission/denial of documents has been filed on behalf of defendants no.1 and 2.

3. Office noting further shows that written statement and affidavit of admission/denial of documents has been filed on behalf of defendant no.3.



4. Perusal of record shows that separate documents with list of documents were filed on behalf of defendants no.1 & 2 as well as defendant no.3.
5. Office noting further reveals that rejoinder/replication to written statement of defendants no.1 and 2, affidavit of admission/denial of documents qua defendants no.1 & 2, affidavit of admission/denial of documents qua defendant no.3 and documents with list of documents, have been filed by the plaintiff vide diary no. 284842/2025. Registry is directed to place the same in appropriate folders.
6. Ld. Counsel for plaintiff submits that she has filed joint rejoinder/replication qua reply/WS of the defendants no.1 to 3 vide diary no.284842/2025, however, the rejoinder/replication on record shows that in the subject matter, there is reference of reply/WS of defendants no.1 and 2 only. Time sought for clarifications in this regard. Let the same be clarified on next date of hearing.
7. No affidavit of admission/denial qua documents of the plaintiff (filed vide diary no.284842/2025) has been filed on behalf of defendants. Time sought by defendants no.1 to 3. Let the same be filed within four weeks.
8. No written statement and affidavit of admission/denial of documents has been filed on behalf of defendants no.4 and 5.
9. Ld. Counsel for plaintiff has submitted that statutory period for filing written statement by defendants no.4 & 5 has already expired and hence, their right to file the same may be closed.
10. Heard. Perusal of order dated 18.10.2024 would show that defendants no.4 and 5 were served and directed to



file their written statement and affidavit of admission/denial of documents as per law, but the same has not been filed till date. The statutory period for filing written statement and affidavit of admission/denial of documents by defendants no.4 and 5 has already expired. Hence, right of defendants no.4 and 5 to file written statement and affidavit of admission/denial of documents stands closed.

11.Let the pleadings be completed as per law.

12.Re-notify the matter for completion of pleadings and further proceedings on **13th August, 2025.**
