These four petitions arise out of two FIRs, being FIR No. 231/2022 dated 05.02.2022, registered at Police Station Rajouri Garden, under Sections 406/420/468/471/34/120B of the Indian Penal Code, 1860, ["IPC"] and FIR No. 199/2021 dated 14.08.2021, registered at E-Police Station Lodhi Colony, South District, under Section 379 of IPC.

2. In CRL.M.C. 2265/2025 & CRL.M.C. 2278/2025, it is contended that the disputes have been settled with two of the accused, namely Mrs. Jasmohinder Singh and Mrs. Manisha Sengar. There are several other accused in both the FIRs with whom no compromise has yet taken place.

3. Mr. Navin Bhardwaj, who is the petitioner in CRL.M.C. 4372/2025 and CRL.M.C. 4363/2025, has sought quashing of the impugned FIRs on merits. However, learned counsel for Mr. Navin Bhardwaj states that he is also desirous of arriving at a compromise with respondent No. 2, the complainant, Mr. Baljinder Singh Malia. Mr. Baljinder Singh Malia is present in person and is also represented by Mr. Sumit Kalra, learned counsel. He submits that he is agreeable to exploring the possibility of a compromise, but that a compromise with all the accused would be preferable, so that the matter can be set at rest.

4. Mr. Navin Bhardwaj and Mr. Baljinder Singh Malia are referred to mediation under the aegis of *Samadhan*, Delhi High Court Mediation & Conciliation Centre, Shershah Road, New Delhi – 110503. However, the Investigating Officers are directed to inform the other accused in both the FIRs about the pendency of the mediation proceedings, so that they may



also join the proceedings if they are so inclined.
