1. Learned respective counsels for the petitioner and respondent no.3 already submitted that they do not wish to file any reply to the captioned IA.

2. No reply to the captioned IA has been filed by defendant no.8A & 9 till date, despite service of the above-captioned IA on 20.5.2025. Even, none is present on behalf of said defendants today to explain in this regard. So, right of the defendant no.8A & 9 to file reply to the above-captioned IA is ordered to be closed.
