Mr. Parveen Kumar Rana, UDC is present from the office of Sub Registrar-1, Kashmeri Gate, Delhi. He submits that the summoned record was transferred to the Department of Archives. Mr. Hiralal is present from the Department of Archives. Diet money of ₹.500/- is paid to Mr. Parveen Kumar Rana and he is discharged. Mr. Hiralal examined as D2W1. He has filed attested copy of the Will dated 12.03.1973 (registered on 15.03.1973) as Ex.D2W1/1. His diet money of ₹.1,000/- paid by learned counsel for defendant No.2 and he is discharged. Copy of Ex.D2W1/1 supplied to learned counsel for the parties. Mr. Rakesh Sharma is present from the office of L&DO.



Learned counsel for defendant No.2 submits that out of the summoned record, four documents are not on record of this case, though their typed copies have been filed. Learned counsel for defendant No.2 seeks passover to 02:00 pm as time is required to get the photocopies of the four documents prepared. Learned counsel for defendant No.5 submits that he will not be available after lunch. Diet money of ₹.1,000/- paid for today to Mr. Rakesh Sharma. He is discharged for today and directed to appear on 16.05.2017 with attested photocopies of all summoned documents.

Learned counsel for plaintiff submits that he is going to move an application for amendment of the valuation clause of the plaint. Copy supplied to learned counsel for defendants.

At this stage, learned counsel for defendant No.2 submits that defendant No.2 is resident of USA, he is old and he is not well. Therefore, defendant No.2 will not be able to appear tomorrow for
