6. The present Petition impugns an Award dated 28.02.2024 passed by the learned Labour Court in Industrial Dispute No.264/2011 [hereinafter referred to as “Impugned Award”]. By the Impugned Award, the learned Labour Court concluded that the Petitioner and Respondent No.4/DIAL have terminated the services of Workmen illegally and have found Petitioner and Respondent No.4/DIAL to be liable for their reinstatement alongwith payment of back-wages and all consequential benefits.

7. This Court, in an order passed today in W.P.(C)9667/2024 has kept the Impugned Award in abeyance till the next date of hearing.
