1. Learned counsel for respondent no. 2 puts in appearance and submits that respondent no. 2, i.e., M/s JAC Air Services Private Limited has amalgamated with JWC Logistics Park Private Limited, having its registered office at 15-23, National Highway 4B, JNPT Highway, Village Padeghar, Panvel-410206, Maharashtra-410206.
2. He further submits that he has instructions to appear for JWC Logistics Park Private Limited.



3. Accordingly, considering the submissions made before this Court, respondent no. 2 is substituted as JWC Logistics Park Private Limited.
4. Let amended Memo of Parties be filed by the petitioner, within a period of one week, from today.
5. Since, respondent no. 2 has been substituted today, let reply be filed by the respondent no. 2, within a period of two weeks from today. Rejoinder thereto, if any, be filed within a period of one week, thereafter.
6. At this stage, learned Senior Counsel for the petitioner in *W.P.(C) 9667/2024* submits that he has not been able to lay his hands on certain documents, which would be material for the purpose of adjudicating the present matter.
