1. *CM APPL. 58791/2026* in *W.P.(C) 9667/2024* has been filed on behalf of the petitioner therein seeking necessary directions to the respondent-workman on the issue as to whether the respondents were gainfully employed during the period when the matter was pending before the Labour Court.
2. Issue notice. Notice is accepted by learned counsels appearing for the respondents.
3. Let reply be filed, within a period of four weeks.
4. Rejoinder thereto, if any, be filed, within a period of two weeks, thereafter.
5. Learned counsel appearing for the petitioner in *W.P.(C) 9693/2024* submits that the Counter Affidavit on behalf of respondent no. 2 has been received by them recently.
6. He, thus, submits that he may be granted time to file rejoinder thereto.



7. Accordingly, let rejoinder be filed, before the next date of hearing.
8. Learned Senior Counsel appearing for the petitioner in W.P.(C) 9667/2024 submits they may also be granted liberty to file rejoinder to the Counter Affidavit filed by the respondents.
9. Accordingly, liberty is so granted.
10. Let rejoinder be filed by the petitioner in W.P.(C) 9667/2024 also, to the Counter Affidavits filed on behalf of the respondents.
11. Let the needful be done, before the next date of hearing.
12. At this stage, learned counsel appearing for respondent no. 3, i.e., M/s HAWK Cargo Services Private Limited in both the matters submits that the corporate name of respondent no. 3 has changed to 'Universal Cargo Solutions Private Limited'.
13. He submits that a fresh Certificate of Incorporation dated 04th September, 2012 has already been issued by the Registrar of Companies, National Capital Territory of Delhi.
14. In this regard, he has handed over to this Court, the requisite document, which is taken on record.
15. Learned Senior Counsel as well as the learned counsel appearing for the petitioners submits that they have no objection if the amended name of respondent no. 3 is taken on record.
16. Accordingly, the petitioners are directed to file amended Memo of Parties, in both the matters, reflecting the name of respondent no. 3 as 'Universal Cargo Solutions Private Limited'.
17. Let the amended Memo of Parties be filed, within a period of one week, from today.
