1. This matter has been received on transfer from the Roster Bench.

CM APPL. 43820/2025 [Stay]

2. This is an Application filed on behalf of the Petitioners, *inter alia*,
seeking the following prayers:

*“A. Stay any proposed demolition action by Respondent No.1 or
otherwise, against the protected JJ Clusters set out in Para 2 above that*



form part of the 675 identified JJ Clusters except after following the DUSIB POLICY 2015.”

3. Learned Senior Counsel for the Petitioner submits that a Coordinate Bench of this Court by an order dated 19.07.2024 directed that status quo shall be maintained with respect to the prayers in the Petition, despite which a Notice has been pasted in the locality of the Petitioner No. 1 at Inder Puri, JJ Colony, Central Delhi-110012 which states that the slums will be removed by Respondent No. 1 on 28.07.2025.

4. Issue Notice.

4.1 Learned Counsel for the Respondents accepts Notice and submits that they need some time to take instructions, and if necessary, file an appropriate Affidavit. Let the Affidavit be filed before the next date of hearing.

5. List on 28.07.2025 before the Roster Bench.

6. In the meantime, and given the fact that the Court has already passed directions of maintaining status quo with respect to the prayers in the Petition, let no coercive steps be taken against the Petitioners in terms of the prayers in the Petition till the next date of hearing.
