1. The present matter is at the stage of admission/denial of documents.
2. Vide order dated 26.07.2024, Hon'ble Court has directed not to grant any unwarranted adjournments to either of the parties and to ensure that the admission/denial of documents is concluded expeditiously.
3. Soft copy and hard copy of Joint Document Schedule are already on record.
4. Hard copies of documents have already been filed on behalf of the plaintiff and defendants no.1 & 3.
5. As per office noting, hard copy of incident news video



clipping in CD and FIR No.275 dated 24.06.2019, which were earlier e-filed vide diary no.148255/2020, filed on behalf of defendant no.2 on 08.07.2024 were returned under objection.

6. Ld. Counsel for defendant no.2 has submitted that he does not wish to rely upon documents which were e-filed by him vide diary no.148255/2020 and the same may be treated as dropped. Not opposed.
7. In view of above submissions, documents e-filed on behalf of defendant no.2 vide diary no.148255/2020 be treated as dropped.
8. Perusal of affidavit of admission/denial of documents filed on behalf of defendants no.1 & 3 shows wherein it is submitted that the said defendants cannot admit or deny document i.e. copy of order dated 27.08.2019. However, at this stage, Ld. Counsel for defendants no.1 & 3 has submitted that he has instructions from main counsel to admit the above said document. Endorsement regarding admission on behalf of defendants no.1 and 3 is made on the document accordingly.
9. In terms of affidavit of admission/denial of documents filed on behalf of defendants and admission made today, three documents of plaintiff have been admitted by the defendant no.2 only and the same are exhibited as Ex.P-1/D-2, Ex.P-2/D-2 & Ex.P-5/D-2 and two other documents of the plaintiff are also admitted on behalf of all three defendants and the same are exhibited as Ex.P-3/D-1 to 3 and Ex.P-4/D-1 to 3.
10. In terms of affidavit of admission/denial of documents filed on behalf of the plaintiff, the plaintiff has admitted



two documents of defendants no.1 and 3, which are exhibited as Ex.D-1 and Ex.D-2.

11.Entries of exhibits have been marked in Joint Document Schedule.

12.Admission/denial of documents stands concluded.

13.Ld. Counsels for both the parties have submitted that the matter may be placed before the Hon'ble Court where they would make their further submissions.

14.At joint request, let the matter be placed before Hon'ble Court for further directions on **29th October, 2024.**
