1. It is submitted that the captioned IA is coming up for

**I.A. No. 5027/2023 (by plaintiff u/O I Rule 10 CPC for

issuing process at the fresh address)**

1. Ld. Counsel for plaintiff has submitted that he has moved
the present application for placing on record fresh address
of defendant no.1. He has further submitted that the
present application may be treated u/S 151 CPC.



2. Heard. In view of submissions, the present application is treated as application u/S 151 CPC. The fresh address of the defendant no.1 as mentioned in the application is taken on record. The amended memo of parties attached with the captioned IA is taken on record.
3. The captioned IA stands disposed off accordingly.

1. It is submitted that the matter is coming up for hearing before the Hon'ble Court on 20.04.2023.
2. As per office noting for 27.01.2023, written statement and affidavit of admission/denial of documents filed by the defendant no.4 have now come on record vide diary no.18975 dated 24.01.2023.
3. Ld. Counsel for defendant no.5 submits that written statement on behalf of defendant no.5 has been filed vide diary no.473054 dated 16.02.2023. However, the same does not find mention in office noting. Let appropriate steps be taken as per law.
4. Ld. Counsel for defendant no.6 submits that written statement on behalf of defendant no.6 has been filed vide diary no.464122/2023. However, the same does not find mention in office noting. Let appropriate steps be taken as per law.
5. The plaintiff may file replication alongwith affidavit of admission/denial of documents qua defendants no.4 to 6 as per law.
6. Issue fresh summons of the suit to the defendant no.1 on the fresh address as mentioned in the amended memo of parties, through all permissible modes for next date of hearing.



7. At request of Ld. Counsel for plaintiff, let fresh summons of the suit be issued to the defendants no.2 and 3 on their addresses available on record through all permissible modes for next date of hearing.
8. Let the pleadings be completed as per law.
9. Re-notify the present matter for completion of service, completion of pleadings and further proceedings on **14th April, 2023.**
