1. Issue notice. Mr. Yeeshu Jain, learned counsel, accepts notice on behalf of the Union of India in all these petitions. Notice upon the remaining respondents be served by all permissible modes, including through learned counsel who appeared on their behalf before the Reference Court.

2. Ms. Mini Pushkarna, learned counsel for the NrDMC, submits that in respect of the same award as challenged in this petition, and the same area, the respondents herein have filed LA. APP. No. 37/2022 [*North Delhi Municipal Corporation vs. Shiv Kumar & Ors.*].



3. Notice in the said appeal as well as application for stay was issued on 14.01.2022 and an interim order of stay of the impugned judgment was passed, subject to the appellant depositing 50% of the decretal amount with the Registrar General of this Court.
4. In view of the aforesaid, the impugned judgments in these cases will also remain stayed until the next date of hearing, subject to the NrDMC depositing 50% of the decretal amount with the Registrar General within eight weeks from today. The amounts deposited be kept in fixed deposit for a period of one year initially, and be renewed periodically, subject to further orders of the Court.
